## Finance Report – Eric Wagner

**SSA** - The SSA for the 2nd Quarter of 2021 was received from the Village.

**Member Dues** - \$2,800 have been received from 56 members for 2021 DTOP Membership Dues, compared to \$1,325 collected last year at this time. Another 66 members have been invoiced. Gift Certificates and DTOP door decals will be mailed shortly to paid members.

**Shopper's Reward** - To date, \$36,230 (out of \$44,350) have been redeemed to merchants vs. \$67,030 at this point last year.

**Extra Reserve Account** - Extra Reserves currently total \$134,424 and are expected to be \$151,090 by year end.

**Snow Reserve Account** - Snow Reserves total \$50,038 and are expected to be \$60,036 by year end.

**Holding Account** - \$58,333 is being held for each of the May, June, and July SSA, and an extra \$20,003 for the August SSA.

<u>Gift Certificates</u> - \$10,560 worth of Gift Certificates have been sold this year compared to \$21,860 redeemed. This is an indication that the consumers are using Gift Certificates from previous years.

Also, attached is the Gift Certificate Reimbursement Analysis which I conducted for the Gift Certificates reimbursed in 2020. As you can see, approximately 22% of the Gift Certificates reimbursed in 2020 were purchased in 2020 and 54% were purchased in 2019, with the remainder in decreasing percentages for previous years. As in years past, Sassetti will calculate a certain amount which we'll be able to write-off.
