Finance Report – Jeff Long

- 1. Winterfest expenses in, looks to be a break-even event
- 2. Snow removal under budget by \$2,000
- 3. Reserves at their goal: Financial plan should meet in March for a plan going forward and reducing the amount being put in reserves (Mike Fox)
 - a. Jeff may dip into Reserves for Shopper's Reward but it is always replenished once SSA comes in just used for cash flow purposes for a month or two
- 4. Shopper's Reward at 211 books given out (vs 190 last year) still below pre-COVID numbers
- 5. Holiday bonus gift certificates: \$5,260 given out (vs \$4,600 last year)
- 6. Extra money purposed in village maintenance agreement changes in 2023 budget
 - a. Village introducing a fall rotation (\$7,000 for DTOP) but quotes are coming in much higher
- 7. New event? Shanon budgeted \$15,000 (would like \$20,000) and budgeting for \$10,000 in revenue (conservative estimate)

Village of Oak Park Updates - Cam Davis

1. Paid out about \$959,000 in business-assisting grant programs (more than 300 grants)

- 2. 133 new business licenses in 2022 (compared to 100 last year) almost all of these are first floor or office new businesses
- 3. Delia's building plans approved on Village side, waiting on permission from Water Reclamation District, hopefully will start building in Spring
